Often the relationship with a patient is also expanded to include their legal representative (usually a family member) who completes a lengthy admission packet containing multiple forms for signature. Historically, this process has been very manual, including printing paper-based forms, driving heavy "big blue book" paperwork packets back to the office to be scanned and uploaded into another system.

With DocuSign and Kno2, a post-acute provider can personalize and streamline the entire admissions process, either remotely or in-person, to ensure a positive experience for the patient and their family as they transition to your organization. Any post-acute provider with PointClickCare (PCC) can benefit from the integration between Kno2 and PCC. Through DocuSign's partnership with Kno2, the patient onboarding process becomes automated. Preparing onboarding packets, signing the patient forms, and storing the signed forms in PCC can all occur seamlessly and digitally. By automating the entire patient onboarding process, your staff will have less of an administrative burden by allowing them to focus more efforts on the patient.

Leverage interoperable solutions to automate the patient admissions process

Starting with the personalization of the admissions packet, a PCC user can send information from the basic patient record in the Electronic Health Record (EHR) or simply add the PCC Patient ID on the envelope within DocuSign eSignature interface. Then the provider can electronically send the admission packet to a designated email address or take the digital forms to a patient's bedside to complete on an electronic tablet.

The signature workflow happens entirely within eSignature, which is a solution that is easy to use and familiar to most patients.

Upon completion of the admission packet by the patient, the signed forms are submitted to Kno2 for efficient filing in the Miscellaneous tab of the patient/resident record in PCC. The filing process steps include:

- Admission documents automatically get sent directly to a patient's chart in PCC, either with or without a manual review in the Kno2 interface
- Automated assignment to the correct patient record in PCC through the Patient ID match or an integrated patient lookup in Kno2
- Automated assignment of individual forms in the admission packet to the corresponding PCC document type
