DocuSign eSignature Upheld in Court as Legal and Valid

DocuSign Certificate of Trust presented as evidence supporting a judgment in favor of the Plaintiffs in Superior Court of California Case No. CUD-13 644781

3300 Clay Street, a property located in the Pacific Heights neighborhood of San Francisco, was the subject of a court case in the Superior Court of the State of California. WB Coyle, one of the property's tenancy-incommon co-owners, had lost his rights of possession of the property after failing to make payments on his portion of the mortgage and was in default of the tenancy-in-common agreement. The remaining coowners were proceeding with a forced sale process of his two units and had executed purchase offers on March 14, 2013, to purchase the units. Mr. Coyle, understanding that he was going to lose his ownership interest, signed lease agreements with two tenants to rent each of the two units in order to undermine the value of the units and the building. He signed these agreements despite an order by arbitration proceedings that neither unit be rented to any third parties.

The challenge

At the center of the dispute were the two lease agreements signed by the tenants. Both Mr. Coyle and the tenants claimed they had signed these agreements on March 1, 2013, prior to the former owner being divested of his ownership. The Plaintiffs in the case, the other coowners of the building, believed the lease agreements had in fact been signed several weeks later, on March 18, 2013, after the divesture, when Mr. Coyle would not legally have been able to lease the units that he no longer owned.

A common challenge in litigation, this case came down to Mr. Coyle and his tenants' word against that of the Plaintiffs. With two sets of witnesses and two different stories, often cases are decided on which witness is more credible. Fortunately in this case, however, the lease agreements in question were executed using DocuSign. Damon Dean, head of DocuSign mobile product management, was called to testify in the case as an expert witness. Mr. Dean provided the court incontrovertible evidence based on DocuSign technology that Mr. Coyle and his tenants were lying about the date when lease agreements were actually signed. Because the documents were signed using DocuSign, Plaintiffs' attorneys were able to show the precise moment that these documents were created, electronically delivered and signed.

DocuSign facts

DocuSign processes millions of documents daily. Yet in every instance that DocuSign documents have been challenged, DocuSign has met the requirements for contract formation and has provided the necessary data to validate the underlying agreement. Solution

Mr. Dean testified about the procedures used by DocuSign to track the time of creation of documents, their delivery to the intended recipients for signature and the date and time that the recipients electronically affixed their signatures. Every signed DocuSign document comes with a certificate of completion that provides proof of the signing process to all parties of the transaction. This certificate includes information from the audit trail to establish the who, what, when and how of the document-signing ceremony. DocuSign maintains a complete, automated history of every viewing, printing, sending, signing, or declining activity on a document. Once a document is signed, the certificate of completion is attached as proof of the signing process to all parties of the transaction.

In this case, DocuSign's certificate showed that although they were backdated to March 1, 2013, the lease documents were actually created on March 18, 2013, delivered by email to the tenants for their signature and signed by the defendants shortly before noon that same day. Mr. Dean's objective, thirdparty testimony and the actual certificates were key factors in the judgment being awarded in favor of the Plaintiffs. According to the Plaintiff's attorneys, Mr. Dean's explanation of how DocuSign works, its reliability and the actual certificates that were entered as key pieces of evidence were vital in supporting the case.
